

Privacy Policy for Abundant Life Church International

Effective Date: July 3, 2025

This Privacy Policy outlines how Abundant Life Church International (hereinafter referred to as "the Church," "we," or "us") collects, uses, and protects the personal information of its members, visitors, and users of its services. This policy is also designed to comply with messaging regulations and requirements.

1. Information We Collect

We may collect the following categories of personal information:

- Name
- Email address
- Mobile phone number
- Address
- · Birth date
- Church affiliation
- Preferences related to ministry areas, events, and communications

We collect this information through church sign-up forms, event registrations, website interactions, donations (tithes and offerings), or other means by which you voluntarily provide your data.

2. How We Use Your Information

We use the information collected to:

- Communicate with you about church activities, classes, and ministries
- Send updates, alerts, and spiritual encouragements via SMS, email, and phone
- Process tithes, offerings, or event payments securely
- Provide access to online courses, sermons, and ministry resources
- Personalize your experience on our platform



3. SMS/Text Messaging

By opting in to receive text messages from our Church, you agree to receive messages related to:

- Event updates
- Prayer requests
- Volunteer needs
- Class reminders
- Giving opportunities

Message frequency varies. Message and data rates may apply.

You may opt out at any time by replying "STOP" to any message. For assistance, reply "HELP" or contact administrator@alcinternational.org

Your opt-in is never shared or sold to third parties.

4. Consent

When you submit your information or opt in to receive messages, you are consenting to our collection and use of your information as described in this Privacy Policy. We honor and respect your right to withdraw consent at any time.

5. Sharing Your Information

We do not sell, rent, or lease your personal information. Your information is only shared with:

- Church staff and ministry leaders for internal ministry purposes
- Third-party service providers that enable our Platform services (e.g., SMS providers, payment processors), under strict confidentiality agreements

6. Data Security

We use secure technologies and organizational measures to protect your data. While no system is 100% secure, we take reasonable steps to protect your information from unauthorized access, disclosure, alteration, or destruction.



7. Your Rights and Choices

You have the right to:

- · Access the personal information we hold about you
- Correct any inaccurate information
- Withdraw consent or request deletion of your information, where applicable
